#1 Tasks (Example Package 1)

- (1) Coaching of the Integration of the Hart Slave communication into an existing software/firmware of a Temperature device. This includes - but is not limited to the following activities:
 - a) Clarification of individual questions on the basis of e-mails and telephone conversations (7h),
 - b) Team-Meetings (2h) and
 - c) Documentation and project status reporting (1h).
- (2) For the work defined under (1), provisionally <u>10 working hours</u> are scheduled for the period *StartDate* to *EndDate*.

#1 Tasks (Example package 2)

- (1) Integration of the Hart Slave communication into the existing software/firmware of a Level device. This includes but is not limited to the following activities:
 - a) Review of the user device software/firmware documentation (if any) (10h),
 - b) Review of the user device source code and identification of interfaces (10h),
 - c) Setup of a development project (5-10h),
 - d) Integration of the sources into the compiler environment (10h),
 - e) Integration of the slave stack to the Uart interface (10h),
 - f) Integration of the slave stack to the timer interface (5h),
 - g) Interfacing the command interpreter with the application (5h),
 - h) Data-Interface to the application (5h),
 - i) Cmd 48 details (if required) (5h),
 - j) Development of special methods (if any) (5h),
 - k) Rough tests of the Hart slave integration (10h),
 - I) Team-Meetings (5-10h) and
 - m) Documentation and project status reporting (5-10h).
- (2) For the work defined under (1), provisionally <u>100 working hours</u> are scheduled for the period *StartDate* to *EndDate*.

#2 Compensation, Execution

- (1) The services specified under # 1 will be compensated with an hourly fee of <u>135.- Euro</u>. VAT is not included in this amount.
- (2) The specific content details of the activity are determined on a case-by-case basis by the commissioner or the project team, as they result from the course of the ongoing work.
- (3) The contractor reports in writing on a monthly basis about work carried out (proof of work) to the head of the department manager and any other persons to be defined.
